# OHIO EPA ISSUES NOTICE OF TENTATIVE DECISION TO ISSUE A VARIANCE FROM CLASSIFICATION AS A WASTE

On June 2, 2020 pursuant to Ohio Administrative Code rule 3745-50-26, the director of Ohio Environmental Protection Agency (Ohio EPA) issued a draft notice tentatively granting a Variance to Envirite of Ohio, Inc. (Envirite), located at 2050 Central Ave SE, Canton, Ohio 44707, and EQ Metals Recovery, LLC (EQ Metals), located at 1533 Allen Ave SE, Canton, Ohio 44707. This is a renewal of Envirite and EQ Metals' current Variance. If issued as a final Variance, certain materials that Envirite and EQ Metals use as process raw materials would not be classified as wastes or hazardous wastes under Ohio's hazardous waste laws. The Agency is proposing to issue this Variance because Envirite and EQ Metals are recycling the metal-bearing residual materials, and using and managing these materials like raw materials and not wastes.

## Why is Envirite and EQ Metals asking Ohio EPA to grant a Variance?

Envirite operates and maintains a hazardous waste storage, treatment, and recycling facility. Envirite accepts metal-bearing hazardous waste and using physical and/or chemical separation and digestion technologies, concentrates the content of the metals of economic interest. EQ Metals then further reclaims and processes these liquid and solid concentrates using noncontact convection driers, producing a Liquid or Solid Concentrate which is a raw material substitute for the metal smelting and chemical manufacturing industries.

Without this variance, some of these recycling activities would be regulated as hazardous waste management activities and EQ Metals would need a hazardous waste facility installation and operation permit (Permit), and Envirite would have to significantly modify the current Permit they have to include these activities. When issued, this variance will allow Envirite and EQ Metals to store the metal-bearing hazardous material before recycling without obtaining a Permit. The draft variance contains the conditions under which the facility must operate if the variance receives final approval. To issue this draft variance, Ohio EPA evaluated Envirite and EQ Metals' application considering the factors in rule 3745-50-24(C) of the Ohio Administrative Code.
