Subject: Modification of PTI Condition

Dear Board of Commissioners:

On July 10, 2013, the Ohio Environmental Protection Agency (Ohio EPA) issued PTI 03-18354, which authorized vertical expansion of the Erie County Sanitary Landfill (Facility) located in Milan, Ohio, to the Erie County Board of Commissioners (Commissioners). Condition 3 of the PTI states:

The Facility's AMDWR is established to be 800 tons. The permittee shall not accept more than 800 tons of waste per day for disposal at the Facility. This tonnage includes both solid waste and exempt waste, including, but not limited to, construction and demolition debris.

On August 22, 2014, Ohio EPA received a request from the Mannik and Smith Group, Inc., on behalf of the Commissioners, to modify Condition 3 of PTI 03-18354. The change was requested to adequately serve the needs of Facility's customers while maintaining slope stability at the Facility.

Ohio EPA has completed a review of the August 22, 2014 request and hereby approves the request. Therefore, Condition 3 of PTI 03-18354 is hereby modified as follows:

The Facility's AMDWR is established to be 800 tons. The permitee shall not accept more than 800 tons of solid waste per day. Each week, the total waste, including solid and other wastes received, shall not exceed 4630 tons.

Nothing in this final action shall be construed to authorize any waiver from the requirements of any applicable federal or state laws or regulations except as specified herein. This final action shall not be interpreted to release the Commissioners from

responsibility under Ohio Revised Code (ORC) Chapters 3704, 3714, 3734, or 6111; under the Federal Clean Water Act, the Resource Conservation and Recovery Act, or the Comprehensive Environmental Response, Compensation, and Liability Act; or from other applicable requirements for remedying conditions resulting from any release of contaminants to the environment.

You are hereby notified that this action of the director of Ohio EPA is final and may be appealed to the Environmental Review Appeals Commission (Commission) pursuant to ORC Section 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within (30) days after notice of the Director's action. The appeal must be accompanied by a filing fee of \$70.00 which the commission, in its discretion, may reduce if by affidavit it is demonstrated that payment of the full amount of the fee would cause extreme hardship. Notice of the filing of the appeal shall be filed with the Director within three (3) days of filing with the Commission. Ohio EPA requests that a copy of the appeal be served upon the Ohio Attorney General's Office, Environmental Enforcement Section. An appeal may be filed with the Environmental Review Appeals Commission at the following address:
