**Subject:** Final Revocation of Class III Water Supply Certificate

Dear Mr. Harmon:

I am writing with regard to your Class III Water Supply Certificate issued to you by Ohio EPA pursuant to Ohio Administrative Code (OAC) Chapter 3745-7. The Proposed Revocation of your Class III Water Supply Certificate was mailed to you on December 4, 2015. Per ORC Chapters 119 and 6109, this action became final because an adjudication hearing was not requested within thirty (30) days.

Pursuant to OAC Rule 3745-7-12(A), the Director may revoke the certificate of an operator upon finding that the operator has knowingly or negligently submitted misleading, inaccurate or false reports, documents or applications, or has fraudulently obtained any certificate, or has operated in such a manner as to have violated provisions of ORC Chapter 6109. Pursuant to OAC Rule 3745-7-12(C), the Director shall take action on all certificates held by the certified operator in cases dealing with fraudulent or falsified information.

You are hereby notified that this action of the Director is final and may be appealed to the Environmental Review Appeals Commission pursuant to ORC Section 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the Director's action. The appeal must be accompanied by a filing fee of \$70.00, made payable to "Treasurer, State of Ohio," which the Commission, in its discretion, may reduce if by affidavit it is demonstrated that payment of the full amount of the fee would cause

extreme hardship. Notice of the filing of the appeal shall be filed with the Director within three (3) days of filing with the Commission. Ohio EPA requests that a copy of the appeal be served upon the Ohio Attorney General's Office, Environmental Enforcement Section.
