JUDGMENT ENTRY

This matter came on before the Court on October 20, 2008 for a hearing on the issue of injunctive relief and imposition of a civil penalty pursuant to R.C. 6109.33. The Court previously granted the State of Ohio's Motion for Default Judgment against Defendants Rodney D. Zeune, Beth A. Mickley f/k/a Beth A Zeune, and The Zeune Company as to liability on all twelve counts of the State's Amended Complaint on August 29, 2007.

The Court finds it has jurisdiction over all of the issues raised by the pleadings, all parties are properly before the Court, and all parties were given notice of the date and time of the final hearing in this matter as required by law. The plaintiff, State of Ohio, and defendant, Beth A. Mickley f/n/a Beth A. Zeune, were present in court with counsel. Defendants, Rodney D. Zeune and The Zeune Company, were not present in court and not represented.

The Court having considered the testimony presented and the evidence offered hereby **ORDERS:**



Defendants, Rodney D. Zeune and The Zeune Company shall be liable, jointly and severally, for a civil penalty in the amount of \$28,600 (twenty-eight thousand, six hundred and 00/100 dollars) to the State of Ohio Drinking Water Protection Fund pursuant to R.C. 6109.30, and Defendant Beth A. Mickley f/n/a Beth A. Zeune, individually, shall be liable for a civil penalty in the amount of \$1,000.00 (one thousand and 00/100 dollars) to the State of Ohio Drinking Water Protection Fund pursuant to R.C. 6109.30, for a total civil penalty of \$29,600.00 (twenty-nine thousand and 00/100 dollars), all for which judgment is herein granted.

Defendants are ordered to pay the costs of this matter.


