Identification and Mapping of Lead Service Mains in the Village of Put-in-Bay Public Water System

The Village of Put-in-Bay lead mapping program consist of two parts, a map of the Villlage Water Distribution System that identifies the type of service connected to each parcel on the system, and an Excel spread sheet that identifies the age of the plumbing system for each building on the distribution system. The spread sheet is set up with each street on a separate spread sheet. The streets are organized in alphabetical order in the binder.

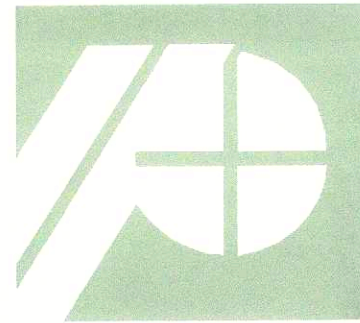
The service areas that could have lead services are limited to the Village Corporation limits on the original water main installed in the 1920's. The parcels that could have lead services are shown in yellow on the map. One of the original mains is on Catawba Ave. and starts at the Village limits and runs in the northerly direction and ends down town on the lake front. Most of the business on Catawba Ave. been expanded and remodeled over the last twenty years and new water services to the main have been installed. The remaining services which may have lead services are primarily single family residential.

Another area of the original main which may have lead services is on Bayview Ave. along the lake front. The line runs westerly from the end of Catawba Ave. to the Village limits. The services are primarily single family residential.

The last area of the original water main runs from the Water Treatment Plant (East side of the Village) in a northerly direction down Toledo Ave. to Delaware Ave., then westerly on Deleware Ave. and ends at Catawba Ave. The majority of business on Toleda and Delaware Ave. have had new services installed. As with the other sections of the old water main, the services which may be lead are primarily single family residential.

The spread sheet for each street will describe each service connection by address, type of service connection material, year building was built, type of suspected plumbing material, and any pertinent notes.
