Narrative of Current Water System

The SR 108 waterline was originally installed in the early 1960's and was later replaced in 2011 with a 12" C900 PVC pipe that serves the Filling Home of Mercy located in Napoleon Township.

This system currently has 8 service taps and when the original was replaced it was found that the service lines were either galvanized or copper tubing.

The first lead and copper sampling period for the District on this system was in 2013. This system was combined with the Road P line and 5 samples were taken from the two lines combined according to the monitoring schedule from the OEPA. If more sampling is required additional sites may have to be added but will be limited due to the number of service connections on both lines.

Most of the homes connected to this line were built in the early 1900's according the Henry County Auditor's website. Construction material of the interior plumbing in most cases has not been verifiable by the District.

Included in this packet is a waterline map of the distribution system of SR 108, a map indicating lead and copper sampling points (blue dots), and names and addresses of the sampling location.
