Re: Lead Mapping Narrative for the Village of Lakemore

The Village of Lakemore drilled the first well in 1939 to provide water to the Village of Lakemore. The Village of Lakemore has expanded the water system over the years by drilling four more wells and extending water mains into a few areas of Springfield Township.

The areas marked in white on the lead map are the core service area for the Village of Lakemore. These are our oldest areas in our community. Because lead water services were commonly used prior to the 1940's, the areas marked in white on the lead map are likely to have lead services. The Village of Lakemore tries to replace lead services whenever possible.

The characteristics of structures and piping solder or plumbing fixtures would be structures in the State of Ohio built before 1998 or that have plumbing material or solder manufactured prior to 1998 may have materials with more than 8% lead and are at a higher risk of contributing lead to the drinking water than materials manufactured after 1998. In addition, structures and plumbing materials manufactured after 2014 were required to have less than 0.25% lead by weight and have the lowest for contributing lead to the drinking water. All structures built between 1985 and 2015 are marked in blue on the lead map.
