<u>Orders</u>

Respondent

I. JURISDICTION

These Director's Final Findings and Orders ("Orders") are issued to Trillium Farm Holdings, LLC ("Respondent") pursuant to the authority vested in the Director of the Ohio Environmental Protection Agency ("Ohio EPA") under Ohio Revised Code ("ORC") 6111.03 and 3745.01.

II. PARTIES BOUND

These Orders shall apply to and be binding upon Respondent and successors in interest liable under Ohio law. No change in the composition of Respondent shall in any way alter Respondent's obligations under these Orders.

III. DEFINITIONS

Unless otherwise stated, all terms used in these Orders shall have the same meaning as defined in ORC Chapters 6111 and 3745, and the rules promulgated thereunder.

IV. FINDINGS

The Director of Ohio EPA has made the following findings:

- 1. Respondent owns and operates Trillium Farm Holdings, LLC, Layer Site 1, which is located at 111995 Croton Road, Croton, Ohio, Licking County.
- 2. Respondent was issued National Pollution Discharge Elimination System ("NPDES") permit number 4IK00014*AD effective December 1, 2012, authorizing the Site's current waste water treatment system ("WWTP") to discharge final effluent to an unnamed tributary of Otter Fork. The unnamed tributary of Otter Fork is considered a "waters of the state" as defined by R.C. Section 6111.01.
- 3. Respondent owns and operates Trillium Farm Holdings, LLC, Layer Site 2, which is located at 9300 Croton Road, Croton, Ohio, Licking County.

- 4. Respondent was issued NPDES permit number 4IK00015*BD modified effective April 1, 2013, authorizing the Site's current WWTP to discharge final effluent to an unnamed tributary of Raccoon Creek. The unnamed tributary of Raccoon Creek is considered a "waters of the state" as defined by R.C. Section 6111.01.
- 5. Respondent owns and operates Trillium Farm Holdings, LLC, Layer Site 3, which is located at 11652 Clover Valley Road, Croton, Ohio, Licking County.
- 6. Respondent was issued NPDES permit number 4IK00016*AD effective December 1, 2012, authorizing the Site's current WWTP to discharge final effluent to an unnamed tributary of Otter Fork. The unnamed tributary of Otter Fork is considered a "waters of the state" as defined by R.C. Section 6111.01.
- 7. Respondent owns and operates Trillium Farm Holdings, LLC, Layer Site 4, which is located at 11492 Westley Chapel Road, Croton, Ohio, Licking County.
- 8. Respondent was issued NPDES permit number 4IK00017*AD effective December 1, 2012, authorizing the Site's current WWTP to discharge final effluent to an unnamed tributary of Raccoon Creek. The unnamed tributary of Raccoon Creek is considered a "waters of the state" as defined by R.C. Section 6111.01.
- 9. Respondent owns and operates Trillium Farm Holdings, LLC, Pullet Site 1, which is located at 9550 Parsons Road, Croton, Ohio, Licking County.
- 10. Respondent was issued NPDES permit number 4IK00018*BD modification effective March 1, 2017, authorizing the Site's current WWTP to discharge final effluent to an unnamed tributary of Bowl Run and subsequently Otter Fork. The unnamed tributary of Bowl Run and Otter Fork are considered a "waters of the state" as defined by R.C. Section 6111.01.
- 11. Respondent owns and operates Trillium Farm Holdings, LLC, Pullet Site 2, which is located at 12280 Croton Road, Croton, Ohio, Licking County.
- 12. Respondent was issued NPDES permit number 4IK00019*CD modification effective March 1, 2017, authorizing the Site's current WWTP to discharge final effluent to Otter Fork. Otter Fork is considered a "waters of the state" as defined by R.C. Section 6111.01.
- 13. Respondent owns and operates Trillium Farm Holdings, LLC, Breeder Layer Site 2, which is located at 9559 Jacob White Road, Croton, Ohio, Licking County.

- 14. Respondent was issued NPDES permit number 4IK00020*BD modification effective April 1, 2013, authorizing the Site's current WWTP to discharge final effluent to Lobdell Creek. Lobdell Creek is considered a "waters of the state" as defined by R.C. Section 6111.01.
- 15. Respondent owns and operates Trillium Farm Holdings, LLC, Pullet Site 3, which is located at 10127 Benner Road, Croton, Ohio, Licking County.
- 16. Respondent was issued NPDES permit number 4IK00021*BD modification effective March 1, 2017, authorizing the Site's current WWTP to discharge final effluent to an unnamed tributary of Lobdell Creek. The unnamed tributary to Lobdell Creek is considered a "waters of the state" as defined by R.C. Section 6111.01.
- 17. Respondent owns and operates Trillium Farm Holdings, LLC, Hatchery/Breeder Pullet Site, ("Site") which is located at 10214 Crouse-Willison Road and 8251 Benner Road, Johnstown, Ohio, Licking County.
- 18. Respondent was issued NPDES permit number 4IK00023*AD effective December 1, 2012, authorizing the Site's current WWTP to discharge final effluent to Bowl Run. Bowl Run is considered a "waters of the state" as defined by R.C. Section 6111.01.
- 19. ORC Section 6111.04(A) prohibits any person from causing pollution or causing any sewage, industrial waste, or other waste to be placed in any location where they cause pollution to waters of the state, except if such discharges occur in accordance with a valid, unexpired NPDES permit issued by the Director or if an application for renewal of such permit is pending.
- 20. Pursuant to Ohio Administrative Code ("OAC") Section 3745-33-02(A), no person may discharge any pollutant or cause, permit, or allow a discharge of any pollutant without applying for and obtaining an Ohio NPDES permit in accordance with the requirements of this chapter.
- 21. Pursuant to ORC 6111.07(A), no person shall violate or fail to perform any duty imposed by sections 6111.01 to 6111.08 of the Revised Code or violate any order, rule, or term or condition of a permit issued or adopted by the director of environmental protection pursuant to those sections. Each day of violation is a separate offense
- 22. The NPDES permits expired on November 30, 2017, when Respondent failed to submit timely NPDES permit renewals in accordance with OAC 3745-33-04(C)(1). Since December 1, 2017, Respondent has been discharging without

an NPDES permit, in violation of OAC 3745-33-02(A) which constitutes a violation of ORC Section 6111.07(A).

- 23. On February 6, 2017, Ohio EPA sent a permit renewal notification letter to the Respondent. The letter required submittal of the NPDES permit renewal applications to the Ohio EPA no later than 180 days prior to the expiration date of the permits, unless the permits contain an earlier submittal date.
- 24. Ohio EPA received untimely NPDES permit applications from Respondent on November 29, 2017.
- 25. The Director has given consideration to, and based his determination on, evidence relating to the technical feasibility and economic reasonableness of complying with these Orders and to evidence relating to conditions calculated to result from compliance with these Orders, and its relation to the benefits to the people of the State to be derived from such compliance in accomplishing the purpose of ORC Chapter 6111.

V. ORDERS

- 1: Upon issuance of the NPDES permit, Respondent shall comply with all terms and conditions of the issued NPDES permit.
- 2. Respondent shall pay the amount of five thousand dollars (\$5,000) in settlement of Ohio EPA's claims for civil penalties, which may be assessed pursuant to ORC Chapter 6111. Within thirty (30) days after the effective date of these Orders, payment to Ohio EPA shall be made by an official check made payable to "Treasurer, State of Ohio". The official check shall be submitted to Carol Butler, or her successor, together with a letter identifying the Respondent, to:

VI. TERMINATION

Respondent's obligations under these Orders shall terminate when Respondent certifies in writing and demonstrates to the satisfaction of Ohio EPA that Respondent has performed all obligations under these Orders and the Chief of Ohio EPA's Division of Surface Water acknowledges, in writing, the termination of these Orders. If Ohio EPA does not agree that all obligations have been performed, then Ohio EPA will notify Respondent of the obligations that have not been performed, in which case Respondent shall have an opportunity to address any such deficiencies and seek termination as described above.

The certification shall contain the following attestation: "I certify that the information contained in or accompanying this certification is true, accurate and complete."

This certification shall be submitted by Respondent to Ohio EPA and shall be signed by a responsible official of the Respondent. For purposes of these Orders, a responsible official is defined in OAC Rule 3745-33-03(D)(1) for a corporation, OAC Rule 3745-33-03(D)(2) for a partnership, OAC Rule 3745-33-03(D)(3) for a sole proprietorship, and OAC Rule 3745-33-03(D)(4) for a municipal, state, or other public facility.

VII. OTHER CLAIMS

Nothing in these Orders shall constitute or be construed as a release from any claim, cause of action or demand in law or equity against any person, firm, partnership or corporation, not a party to these Orders, for any liability arising from, or related to activities occurring on or at the site.

VIII. OTHER APPLICABLE LAWS

All actions required to be taken pursuant to these Orders shall be undertaken in accordance with the requirements of all applicable local, state and federal laws and regulations. These Orders do not waive or compromise the applicability and enforcement of any other statutes or regulations applicable to Respondent.

IX. MODIFICATIONS

These Orders may be modified by agreement of the parties hereto. Modifications shall be in writing and shall be effective on the date entered in the journal of the Director of Ohio EPA.

X. NOTICE

All documents required to be submitted by Respondent pursuant to these Orders shall be addressed to:

XI. RESERVATION OF RIGHTS

Ohio EPA and Respondent each reserve all rights, privileges and causes of action, except as specifically waived in Section XII of these Orders.

XII. WAIVER

In order to resolve disputed claims, without admission of fact, violation or liability, and in lieu of further enforcement action by Ohio EPA for only the violations specifically cited in these Orders, Respondent consents to the issuance of these Orders and agrees to comply with these Orders. Compliance with these Orders shall be a full accord and satisfaction for Respondent's liability for the violations specifically cited herein.

Respondent hereby waives the right to appeal the issuance, terms and conditions, and service of these Orders, and Respondent hereby waives any and all rights Respondent may have to seek administrative or judicial review of these Orders either in law or equity.

Notwithstanding the preceding, Ohio EPA and Respondent agree that if these Orders are appealed by any other party to the Environmental Review Appeals Commission, or any court, Respondent retains the right to intervene and participate in such appeal. In such an event, Respondent shall continue to comply with these Orders notwithstanding such appeal and intervention unless these Orders are stayed, vacated or modified.

XIII. EFFECTIVE DATE
