ISSUANCE OF A DRAFT RENEWAL PERMIT

On July 16, 2021, Ohio EPA issued a draft Ohio Hazardous Waste Renewal Permit to Wright Patterson Air Force Base (WPAFB), U.S. EPA Identification Number OH7 571 724 312, for its facility located at 1450 Littrell Road, WPAFB, Ohio 45433 in Greene County. The purpose of this permit is to allow Wright Patterson to continue to store containerized hazardous waste and mixed waste from other department of defense installations prior to being shipped off to other permitted hazardous waste treatment, storage, and disposal facility. No hazardous waste disposal occurs at the facility.

Currently, the State of Ohio is not authorized by U.S. EPA to issue a permit for organic air emissions (40 CFR Part 264, Subparts AA, BB, and CC) from hazardous waste storage units. U.S. EPA has drafted a RCRA permit to address organic air emissions from hazardous waste storage units. U.S. EPA's draft permit and the State of Ohio's draft permit have been issued concurrently and both share the same comment period. The public comment period begins on July 19, 2021 and ends on September 2, 2021. For the permit application to receive final approval, Ohio EPA must determine that the permit application is complete and meets appropriate standards and that the applicant has a history of compliance with relevant environmental laws and demonstrates sufficient reliability, expertise, and competency to operate a hazardous waste facility.
