Dear Mr. D'Agostino:

On July 8, 2021, the Ohio Environmental Protection Agency (Ohio EPA), Division of Materials and Waste Management (DMWM), Northwest District Office (NWDO) received the Compliance Monitoring Program Plan (CMPP), dated July 7, 2021 (previous version dated May 2021), which was submitted by Materion Brush Inc. The CMPP was submitted to address Order No. 5 of the December 23, 2011, Director's Final Findings and Orders (DFFOs). Ohio EPA has reviewed the CMPP to determine compliance with Order No. 5 of the DFFOs and with the applicable requirements of Ohio Administrative Code (OAC) Rule 3745-27-10 [effective August 15, 2003]. The CMPP documents the procedures to be used for monitoring the ground water beneath the facility, for monitoring the surface water quality of the Portage River and for maintaining hydraulic capture of the ground water contamination from the facility in the Intermediate/Deep aquifer by pumping of production well PW-2 for the Materion Brush Closed North Landfill, (Facility), located at 14710 West Portage River South Road, Elmore, Ohio.

I have reviewed the applicable information and hereby approve the Compliance Monitoring Program Plan dated July 7, 2021.

You are hereby notified that this action of the Director is final and may be appealed to the Environmental Review Appeals Commission pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the Director's action. The appeal must be accompanied by a filing fee of \$70.00 made payable to "Treasurer, State of Ohio." The Commission, in its discretion, may reduce the fee if by affidavit it is demonstrated that payment of the full amount of the fee would cause extreme hardship. Notice of the filing

of the appeal shall be filed with the Director within three (3) days of filing with the Commission. Ohio EPA requests that a copy of the appeal be served upon the Ohio Attorney General's Office, Environmental Enforcement Section. An appeal may be filed with the Environmental Review Appeals Commission at the following address:
