RECEIPT OF RENEWAL APPLICATION

On August 31, 2021, Ohio EPA received a Renewal Hazardous Waste Facility Installation and Operation Permit Application from Vickery Environmental Services, Inc., U.S. EPA Identification Number OHD 020 273 819, for its facility located at 3956 State Route 412, Vickery, OH 43464 in Sandusky County. Vickery Environmental Services, Inc., treats reactive hazardous waste by disposing waste through deepwell injection at their deepwell injection sites. The purpose of this permit is to allow Vickery Environmental Services, Inc. to continue the following hazardous waste management activities: tank treatment and storage, miscellaneous unit treatment, post closure, and corrective action.

For the Permit Application to receive final approval, Ohio EPA must determine that the Permit Application is complete and meets appropriate standards and that the applicant has a history of compliance with relevant environmental laws and demonstrates sufficient reliability, expertise, and competency to operate a hazardous waste facility.
