In accordance with Section VI (2) of the Directors Final Findings and Orders effective December 31, 2024 (DFFOs)¹, August Mack Environmental Inc. (AME), on behalf of Material Sciences Corporation (MSC), submitted the *Wetland and Downstream Sawmill Creek Sampling Work Plan*² on April 18, 2025. This work plan is just one component of the RFI Workplan. It is intended to establish a baseline dataset of conditions in Sawmill Creek downstream of the MSC property as well as further delineate impacts to the wetland on the northern adjacent property.

Ohio EPA has reviewed and, with this correspondence, approves the April 18, 2025, *Wetland and Downstream Sawmill Creek Sampling Work Plan*.
