NOTICE OF VIOLATION – ACTION REQUIRED

Subject: Failure to Report Sample Results on Time for Water Quality Parameters in the Distribution System; Violation Type 53; Violation ID: 227; Facility ID: 1753658

Dear Ms. Ward:

Optimal Water Quality Parameters (OWQP) were designated for this facility in the June 28, 2006, plan approval. That plan approval required collection of two samples of orthophosphate, total alkalinity, and pH at least a week apart from the same ten taps in each six-month monitoring period. Results are required to be reported to the Ohio Environmental Protection Agency (Ohio EPA) by the 10th day of the month after the water system receives the results. During the January – June 2025 monitoring period, some of these sample results were submitted after the 10th day of the month after the water system received their results.

Galion City is in violation of Ohio Administrative Code (OAC) 3745-81-90 (A)(1) for failure to report the results of required WQP sampling to Ohio EPA within 10 days following the end of the month in which the system received the sample results. WQP samples were collected in the distribution system during April – June 2025, but results were not reported to Ohio EPA until July 23, 2025. Therefore, the WQP data was not submitted to Ohio EPA within 10 days following the end of the month in which sample results were received and the distribution WQP data was reported late for the January – June 2025 monitoring period.

Ensure OWQP sample results are reported on time in the future.

ACTION REQUIRED:

1. **As soon as practical, but no later than one year after** the date of this letter, notify your customers of this violation using the enclosed instructions and public notice.
2. **Within 10 days** of completing the public notification requirements, complete and send a verification form with a copy of the public notice to Justin Bowerman at justin.bowerman@epa.ohio.gov.

PUBLIC NOTICE INSTRUCTIONS AND VERIFICATION FORM FOR COMMUNITY PUBLIC WATER SYSTEMS WITH TIER 3 VIOLATIONS

The owner or operator of a community public water system with a Tier 3 violation or situation shall notify the persons served by the public water system as soon as practical but **no later than one year** after the system learns of the violation. At a minimum, community public water systems must issue the notice by **mail or other direct delivery**.
